# **Comprehensive Medicolegal Training: Establishing a Solid Foundation for Success**

# eMedicoLegal - Web-Based Learning Systems

This cloud-based learning resource is designed for physicians (including chiropractic physicians), psychologists, physical therapists, nurses, and other healthcare providers who need the critical knowledge and skills to succeed in the medicolegal field. This course integrates with Chiropractic Forensics, Advanced Online Clinical Training in Neuromusculoskeletal Medicine.

This over hundred hours learning experience comprises web-based presentations, interactions, exercises, quizzes, activities, and assigned readings. It consists of nine monthly segments, each containing four weekly modules involving an average of 2.5 hours of learning. A dynamic cloud-based platform (Kajabi) delivers the content as a "drip," i.e., the learner has access to the current (and past) content delivered weekly. It is then available 24/7.

The first segment provides the basic foundation (including potential arenas, clients, and services). You will learn how to use the AMA *Guides to the Evaluation of Permanent Impairment*, Sixth Edition. Next, you will learn about ethics and medicolegal Issues, the use of science, research and biostatistics, psychosocial issues, and personality and psychological issues. You will then learn how to evaluate critical issues, including assessing clinical issues with a biopsychosocial perspective, assessing the appropriateness of care: using science and guidelines, causation and apportionment analysis, functional assessment, workability, and disability. With this understanding, we will explore specific musculoskeletal injuries. Our next phase is exploring various arenas where you can provide service and the types of services. We conclude the training by developing expert witness skills.

This learning opportunity is not for someone unwilling to devote the time and funds required to succeed. You may stop at any time. If the learner effectively applies the information provided, there should be an excellent return on this investment.

# **Objectives:**

As a result of participation in this learning experience, the participant will be able to:

- 1. Discuss the opportunities and challenges for providing medicolegal expert services.

- 9. Demonstrate the ability to analyze causation and apportionment using evidence-based medicine.
- 10. Discuss the concept of maximal medical improvement.
- 11. Demonstrate the ability to assess permanent impairment.
- 12. Explain the process of function and work ability assessment.
- 13. Demonstrate how to access disability duration.
- 14. Explain critical issues in evaluating musculoskeletal (spine, upper extremities, and lower extremities), pain, nervous system, mental and behavioral, and medical disorders.

# **Required Resources**

The learner must have internet access via computer or tablet.

Participants are required to obtain publications (virtual or print) from the American Medical Association (AMA). This training program is separate from the AMA. The cost of these publications, a total of approximately \$890, is not included in the training fee. All medicolegal experts are encouraged to have these publications.

### **Primary Faculty**

### Fees

Participants must subscribe to the AMA *Guides* All Access digital resources the American Medical Association offers at \$599 for one year. Required textbooks are approximately \$400. Therefore, the total cost is approximately \$5,105, plus any additional publications or website subscriptions you may want to purchase.

Based on IME Fee Survey, the average income from 3 IMEs (@ \$1,800/evaluation) = \$5,400. Therefore, it is probable that you will have a strong return on your investment. Note: Other expenses will be incurred in developing a new practice, and your fees may vary from the reported average.
